

When a STIM affiliated music creator dies, the right to collect remuneration from STIM (and NCB) can pass to the parties to the estate. The right subsists until the end of the seventieth year after the year of death of the creator. Remuneration is distributed from STIM to the parties to the estate in accordance with the estate inventory deed and other official documents determining the distribution of an estate, unless the parties request a different distribution by filling in this document.

ATTENTION! This document must be signed by all parties to the estate, regardless of the percentages stated.
